## LA PERRUCHE WHITE ROUGH-CUT CUBES

**Processing method** « La Perruche » rough-cut cubes are made from Pure Cane sugar using an exclusive method to obtain white rough-cut cubes packed in a cardboard box.

**Ingredient** Cane sugar.

TRACEABILITY	Our traceability management respects GS1 standards. We put on each sent pallet (homogeneous or not) at least a standard label EAN 128 bearing a Serial Shipping Container Code which makes the link with our production, storage and shipping operations.
